## **Make a comment during the meeting:**

1. To participate in the teleconferenced meeting, you may call by phone to share your comments live at 925-671-5275.
2. Speakers are encouraged to call 10 minutes before the meeting due to a live-streaming lag- time, and will be placed on hold until the Public Comment period.
3. Comments are limited to three minutes per speaker.
4. The Committee will accept, but not discuss comments. When it is your turn to speak, staff will invite you. You must mute your speakers if you are streaming live or there will be feedback during the meeting.
