1. ZONING ORDINANCE AMENDMENT - ACCESSORY DWELLING UNITS, CITY-WIDE

The Planning Commission is requested to hold a public hearing to consider a recommendation to the City Council regarding a proposed zoning ordinance amendment related to modifications to the existing Accessory Dwelling Unit (ADU) ordinance, Section 18.20.095 . The amendments are proposed to be consistent with State Law and associated determinations made by the State on recently adopted ADU provisions.
